OFF-LICENCE

Section 17 to 20, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), **THE ASHWOOD FINE WINE & FOOD COMPANY LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **352 Lytton Road, Gisborne,** and known as "**Leaderbrand**", to **any person for consumption off the premises** and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

On site sales

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Friday

9.00am to 6.00pm

- (c) The licensee must have freely available at any display table or bar, drinking water for patrons, while alcohol is being supplied free as a sample.
- (d) The holder of a manager's certificate or a properly notified manager shall be on duty and on site at all times alcohol is sold.
- (e) A Host Responsibility Policy must be maintained and displayed at all points of sale and the Licensee must ensure all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restriction on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

Remote sales

- (g) No alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.
- (h) Alcohol may only be delivered between the hours of 6am and 11 pm.
- (i) Proof of age for sales via internet, phone and order form, must be consistent with the intent of the Sale and Supply of Alcohol Regulations 2013.
- (j) The information, outlined in regulation 15 in the Sale and Supply of Alcohol Regulations 2013, relating to remote sellers, is met.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of certificates, this certificate expires on:
